

TERMS AND CONDITIONS – DIE EILAND FACILITIES & FUNCTIONS

We thank you for your cooperation and hope that you enjoy your stay with us. We trust that your function will be a memorable one and that we may have the pleasure to be of service to you again in the future.

General terms and conditions:

1. Applications will only be considered with the understanding that the decision of Management is final.
2. No sub-letting or any profit-making venture is allowed.
3. The applicant accepts full responsibility for the facility hired and any expenses incurred.
4. The applicant will personally be held responsible for the behavior of his/her guests and will ensure that a responsible person remains at the function until the last guest has departed.
5. The applicant will be held personally responsible for settling the account in full in accordance with the payment terms laid down.
6. The applicant will be held responsible for any damage caused by himself / herself or any of their guests to the premises or property.
7. Minor children will be under responsible adult supervision for the duration of the function.
8. SCAS does not accept responsibility whatsoever for any loss of life or loss or theft of cash, bags, keys, clothing, hired items, valuables or any property whatsoever, or for damages or loss of any vehicle in the parking area or on the premises, nor for any damages or injury to any person(s).
9. SCAS will not be held responsible for the safekeeping of any property or goods brought onto the property by clients, suppliers or agents.
10. The applicant will leave the area in the same condition as found unless otherwise arranged.
11. All laws and statutory stipulations shall be honored, including the smoking Act. The braai area is the only designated area.
12. SCAS Management / staff may at any time visit the hired area. In the event of any unruliness, any reasonable request by the staff member will be honored.
13. No alcoholic beverages may be brought on to the premises.
14. Guests are limited to the hired area and the toilets.

15. A deposit is payable on reservation and must be paid into our banking account within 7 days of the booking. Failing to pay the deposit could result in the cancellation of the function.
16. The full fee is payable after approval by Management. If not paid in full 7 days after notification, the deposit as well as the hiring of the facility will be forfeited.
17. All monies owed to SCAS is payable prior to the start of the function, unless alternative arrangements have been made with Management.
18. Cleaning of crockery will be done by the Client.
19. All prices quoted are subject to fluctuation in the cost structure at the time of the quotation, and without prior notification.
20. Final figures of guests attending, as well as changes, must be handed in at least 5 days before the function. Changes after then could result in full catering fees being charged.

Payment terms and conditions:

1. The reservation will not be confirmed unless the deposit has been paid.
2. Deposit is not refundable.
3. In case of any additional costs for function, a final Invoice will be prepared and should be settled immediately.
4. All prices are inclusive of VAT.
